**Sub: Conferment of Autonomous Status to Silicon Institute of Technology,
Bhubaneswar**

Sir,

In pursuance of the UGC letter under reference, the Vice Chancellor has been pleased to accord approval on conferment of academic autonomy in favour of Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar under Section 5 (iii) of the BPUT Act, 2002.

The grant of academic autonomy shall be subject to the following terms & conditions/guidelines.

1. The Autonomy shall be operative for ten years from the Academic Session 2018-19 or until further orders whichever is earlier.
2. The autonomy is granted to Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar as conferred by UGC, New Delhi vide file No. F.22-1/2018 (AC) dated: 28.05.2018.
3. Admission of students to the UG & PG programmes offered by the college shall be in conformity with the provisions of 'The Orissa Professional Educational Institution (Regulation of Admission and Fixation of Fee) Act', 2007 as amended from time to time.

4. The college shall admit students in respect of the courses for which Academic Autonomy is conferred against the syllabus, course-content etc. to be submitted by the college. The method of conducting examination, evaluation, award of grades would be primarily guided by the provisions of the Academic Regulations of the University.
5. The college shall have the power to make its own rules, regulations or by-laws in consonance with the UGC Guidelines for Autonomous Colleges and Biju Patnaik University of Technology and the laws framed thereunder for the purpose of fulfilling the objectives for conferring the autonomy status.
6. The college shall have a Governing Body, Academic Council and appropriate Board of Studies and other committees as per requirement of UGC with adequate number of University representatives to ensure the quality and standards of courses for the subjects and shall be comparable to the quality standards prescribed by the University / UGC Guidelines for Autonomous Colleges.
7. The University shall approve the results of approved courses and confer degree to the successful candidates as per UGC Guidelines for Autonomous Colleges subject to prior approval of the results after each semester.
8. The Board of Management of the University shall have power to revoke the autonomy at any time after scrutiny and after due notice of such intention to the college before the expiry of such period granted from time to time, in case of deteriorating standards or for any other cause as deemed fit.
9. The Board of Management of the University shall have power to monitor the functioning of the college through periodic review. It will be have power for inspection or cause inspection to be made by such person or persons to the college and its buildings, workshops etc. and would also have the right to scrutinize the process of teaching, examination and other work conducted or done by the college. The Board would also have the power to make such inquiry and issue notice to the Principal on the academic matter of the college.
10. Notwithstanding anything stated above, conferment of autonomous status to Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar shall however be subject to fulfilment of such standing orders, rules, regulations, guidelines and directions issued

from time to time by the Government / UGC / AICTE and the University and as amended from time to time.

11. The college has indemnified the University through an affidavit against the possible risk of financial and other liabilities / involvements / responsibility associated with the Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar shall applicable mutatis mutandis.
