This is regarding Compliance Report submitted by **Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar-751024, Odisha** for the UG Engineering programs which were accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30.06.2021. The programs were granted accreditation for the Academic Year 2021-22 i.e. upto 30/06/2022 on account of present pandemic situation due to Corona Virus.

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for further 3 years. **Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar-751024, Odisha** should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Silicon Institute of Technology, Silicon Hills, Patia, Bhubaneswar-751024, Odisha** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
